ADMINISTRATIVE ORDER NO. 5.111-8/20*

IN RE: PROCEDURES FOR TEMPORARY AND CONCURRENT CUSTODY PROCEEDINGS

Chapter 751 of the Florida Statutes provides for the temporary or concurrent custody of a minor child to an extended family member having physical custody of the minor child, to enable the custodian to provide for the welfare of and give complete care to the child. Temporary and concurrent custody proceedings are filed at the Main Judicial Center and the branch courthouses. Uniform procedures will ensure the timely disposition of the temporary and concurrent custody proceedings.

NOW, **THEREFORE**, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

A. CASE FILINGS

- 1. Temporary and Concurrent Custody Petitions will be assigned in accordance with Administrative Order 5.101. If a related Domestic Relations case is identified at initial screening or on the Notice of Related Case Form, the Clerk of Court shall assign the newly filed case to the same division as the previous case.
- 2. The Clerk of Court shall forward Temporary and Concurrent Custody Petitions filed by self represented litigants to the case manager divisional email inboxes.
- 3. An internal case management review of the file will be undertaken by the Court prior to the setting of the Final Hearing on the Petition for Temporary or Concurrent Custody.
- 4. Pursuant to Fifteenth Judicial Circuit Administrative Order 5.307, a copy of a Live Birth Certificate for any minor child(ren) involved in a Petition for Temporary or Concurrent Custody must be filed in the case.
- 5. Pursuant to Fifteenth Judicial Circuit Administrative Order 5.109, a Date of Birth Form for all parties, including minor child(ren) involved in a Petition for Temporary or Concurrent Custody, must be filed in the case.

- 6. If the Petition for Temporary or Concurrent Custody is incomplete or requires additional information or documentation, the Court will enter a status order outlining the deficiencies or missing information.
- 7. Failure to comply with the Court's requirements on the status order could result in the dismissal of the case.

B. HEARING AND DISPOSITION OF THE CASES

- 1. <u>Filings by Self Represented Litigants</u>: Upon completion of the case management review, the case manager will prepare an Order Setting Hearing on the Case.
- 2. <u>Filings by Attorneys</u>: A hearing is not be requested unless there is compliance with the checklist attached as Exhibit A and the attorney believes that there is full compliance with Chapter 751. Requests for hearings are to be made in accordance with the Divisional Instructions.
