ADMINISTRATIVE ORDER NO. 2.709-9/08*

IN RE: PROCESS SERVERS SECTION 48.29 (e) GUIDELINES

The Fifteenth Judicial Circuit has established a certification program for process servers. A misdemeanor involving "moral turpitude or dishonesty" may invalidate a person's certification or make them ineligible for certification as a process server. Section 48.29 (e), Florida Statutes (2007) does not specifically cite offenses which relate to moral turpitude.

NOW, THEREFORE, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

Reference shall be made to Addendum I to this Administrative Order for citing specific offenses, which relate to acts of "moral turpitude and dishonesty". Further, Addendum I shall serve as a guideline for purposes of clarifying the interpretation of Section 48.29 (e), Florida Statutes (2007).
