ADMINISTRATIVE ORDER NO. 3.908-2/16

RE: ESTABLISHMENT OF ENGLE PROGENY
TOBACCO LITIGATION TRIAL DIVISION AND
REALLOCATION OF DIVISION "AI" CASES

To better serve the citizens of Palm Beach County, the Fifteenth Judicial Circuit has found that a more effective and efficient use of judicial resources is best achieved by transferring Engle Progeny Tobacco Litigation cases to one division to be presided over by one judge.

NOW, THEREFORE, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

1. Effective February 1, 2016, all Engle Progeny Tobacco cases shall be transferred to Circuit Civil Division "AI".
2. The Clerk of Court shall reassign all of the Engle Progeny Tobacco cases listed in the attached Exhibit "A" into Circuit Civil Division "AI".
3. In order to equalize the judicial caseload of the reassignment of the tobacco cases into Circuit Civil Division "AI", the Clerk of Court shall randomly reassign all the cases listed in the attached Exhibit "B" from Circuit Civil Division "AI" amongst the other Circuit Civil Divisions.
4. No later than February 18, 2016, the Clerk of Court shall provide to Court Administration a list of the divisions to which the cases were reassigned.
5. The Clerk of Court shall prepare a Notice of Reassignment and serve either electronically or by United States Mail the Notice of Reassignment on the Plaintiff.
 - a. The Notice shall be docketed and available for public viewing within twenty-four (24) hours of the reassignment.
 - b. The Notice shall contain a directive to the Plaintiff to serve the Notice of Reassignment on all parties, in accordance with Rule of Judicial Administration 2.516. The Clerk of Court shall file and serve the Notice of Reassignment on the Plaintiff no later than February 18, 2016.

6. Within seven (7) business days of the service of the Notice of Reassignment, the Plaintiff shall serve in accordance with Rule of Judicial Administration 2.516, a copy of the Notice of Reassignment on all parties who have not been dismissed or dropped from the action. The Plaintiff shall also file a Notice of Service of the Notice of Reassignment ("Notice of Service") with the Clerk of Court. The Notice of Service is to include a complete and accurate service list.
