SUPPORT WRITS OF BODILY ATTACHMENT

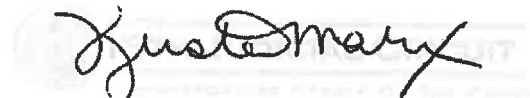

The Palm Beach County Sheriff's Office and the Department of Revenue (DOR) have identified over 200 outstanding active DOR Child Support Writs of Bodily Attachment (Writs) in Palm Beach County. These cases are set forth in Exhibit "A" which is attached to this Administrative Order. DOR has reviewed and agrees that the list of cases attached in Exhibit "A" are all either closed, cold cases, or cases where the non-custodial parent is now paying via income deduction or Income withholding order. DOR has moved for the recall of these outstanding writs as the manpower required for service and execution and record-keeping, along with the physical housing and storage of these writs, places a tremendous burden on the Palm Beach County Sheriff's Office, Clerk of Court, and DOR. DOR agrees that these writs should be quashed.

NOW, THEREFORE, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

1. All outstanding Department of Revenue Child Support writs issued in the cases set forth in Exhibit "A" are hereby **RECALLED AND QUASHED**. Any related outstanding motions for contempt filed by the Department of Revenue on these cases are **DENIED**.
2. The Palm Beach County Clerk of Court shall deliver to PBSO one certified copy of this Administrative Order which shall serve as the Order to Recall and Quash for each case set forth in Exhibit "A" as if separately ordered.
3. The recalling of the active writ does not terminate a party's obligation to pay child support as required by a Final Order of Final Judgment entered by the Court.
4. The party owed child support, either on its own, with a private attorney, or with renewed services from the DOR Child Support Enforcement Program, may seek remedies for enforcement with the court.
5. The Clerk of Court is to file a copy of this Administrative Order in the identified cases.
