# FIFTEENTH JUDICIAL CIRCUIT ALTERNATIVE DISPUTE RESOLUTION OFFICE

## Danni Hoefling, Director

Danni Deaver Hoefling is the Director of the Alternative Dispute Resolution Office for the Fifteenth Judicial Circuit. She has been employed with the Circuit as a Florida Supreme Court certified Family, Dependency and County Mediator since 1996. During her tenure with the Circuit, Danni served on the Supreme Court's Mediator Ethics Advisory Board (2000-2008). In 2019, she was appointed by Chief Justice Charles T. Canady to serve on the Alternative Dispute Resolution Rules and Policy Committee. She earned a Bachelor of Science Degree from Meredith College in North Carolina and a Master of Science Degree from Nova Southeastern University in the school's first Master's program in Conflict Analysis and Resolution.

Ms. Hoefling began her mediation career in 1986, in North Carolina, as a mediator with one of the early North Carolina mediation programs. She was certified as a Florida Supreme Court Mediator in 1991 and was hired as a mediator in 1993 by the Eleventh Judicial Circuit, Miami. A pioneer in the mediation field, Ms. Hoefling has more than thirty years of experience in mediation with twenty-five of those years spent mediating in the Florida Courts System.

#### Lourdes Castillo, Mediator

Lourdes Castillo is a senior member of the Alternate Dispute Resolution Office. She has been mediating in South Florida for ten years. Ms. Castillo is a first-generation Cuban-American and a native Spanish speaker. She received her undergraduate degree from Rutgers University and earned a Juris Doctor from New York Law School. Ms. Castillo practiced law in several jurisdictions in the United States for thirty-three years, including criminal, bankruptcy, trust and estates, dependency, and real estate law. Practicing across various legal disciplines has honed Ms. Castillo's ability to communicate with diverse clients in all stages of life. She brings her decades of legal experience as well as her passion to help others to her Alternate Dispute Resolution practice.

### **Kelly Henderson, Mediator**

Kelly Henderson has been a staff mediator with the Fifteenth Judicial Circuit since May of 2014. The Florida Supreme Court certified Mr. Henderson as a Circuit and County Court Mediator in 1998, a Family Court Mediator in 2005, and, a Dependency Court Mediator in 2015. In 2018, Supreme Court Justice Charles Canady appointed him to a four-year term on the Mediator Ethics Advisory Committee.

Prior to his work for the Fifteenth Judicial Circuit, Mr. Henderson's career included time spent as General Counsel to the Community Partnership for the Homeless in Miami, as an attorney in private practice and 5 years as a Senior Trial Attorney with the United States Equal Employment Opportunity Commission.

Mr. Henderson earned his Juris Doctor from Nova Law School in 1993 and a Bachelor of Arts in Philosophy from the University of Wisconsin - Madison in 1977.

## Benjamin C. Johnson, Mediator

Mr. Johnson was hired as a Fifteenth Judicial Circuit Family Mediator in July 2020. Prior to his work as a staff mediator, Mr. Johnson volunteered as a County Court Mediator with the Circuit. In that role, he received a great deal of training and teaching from the Alternative Dispute Resolution Department. In addition to mediating in nonprofit, private, and charter schools, Mr. Johnson mediated conflict in the Army and was elected as the Suicide Prevention Officer for Delta Company 1-124 Infantry Regiment. After working and learning alongside an Army Psychologist and a Family Mediator, he decided to pursue a career path as a Mediator and obtained a degree in Conflict Resolution and Reconciliation from Abilene Christian University in an endeavor to pursue peace for himself and others.

## Jeffrey J. Kash, Mediator

Jeffrey J. Kash has been a full-time family and dependency mediator for the Fifteenth Judicial Circuit since February 2018. He is a Florida Supreme Court certified Family, Dependency and County Mediator. He earned his Juris Doctor from Vermont Law School and his Bachelor of Arts from Pennsylvania State University.

Prior to moving to Florida to mediate full-time, Mr. Kash practiced family law in northeastern Pennsylvania for thirty years. As a managing partner in the firm of Kash Fedrigon Belanger LLC, Mr. Kash represented countless clients in contested child custody and complex divorce matters in the trial and appellate courts. Ms. O'Brien serves as a committee member for Grandma's Place, an organization that provides emergency shelter for children (ages birth through twelve), who have been removed from their homes due to abuse, neglect or abandonment, as well as respite care for caregivers of children with special needs.
