Trial Court Administrator Susan Ferrante Retires



After more than 20 years as Trial Court Administrator for the Fifteenth Judicial Circuit, **Susan D. Ferrante** retired in January.

As Trial Court Administrator, Ferrante worked side-by-side with eight successive Chief Judges, including Judge Emery J. Newell, Judge R. William

Rutter, Judge Daniel T. K. Hurley, Judge Jack H. Cook, Judge Richard L. Oftedal, Judge Walter N. Colbath, Jr., Judge Edward H. Fine and current Chief Judge Kathleen J. Kroll, each serving one or more 2year terms. With each presiding Chief Judge, Ferrante adapted Court Administration's priorities to meet the evolving demands of a rapidly growing county, addressing all judicial and non-judicial matters for the circuit including financial and personnel matters, security, planning, technological developments and more. In a letter written by Chief Judge Kathleen Kroll, Ms. Ferrante was praised for the circuit's many accomplishments during her administration.

Ferrante's tenure spanned two decades during which the ways in which court and governmental offices function has forever changed, with local, national and international events (such as the Oklahoma bombing, September 11th, the threat of mail terror attacks or a flu pandemic, and violence against judges, court personnel and attorneys) affecting everything from daily protocol to the material design of court buildings. This same period was categorized by a rapidly growing local population and changing demographics, and constantly evolving priorities for the courts — such as expanded awareness of domestic violence issues, new approaches to prevent recidivism in criminal courts or the escalation of problems with juvenile offenders, a new emphasis on unifying family courts and a focus on identifying issues specific to the elderly. Ferrante was involved in the development and construction of the Central Courthouse (opened in 1995) and ongoing expansion of satellite facilities. She spent the "Your leadership, direction and guidance have truly made the Fifteenth Judicial Circuit a model court for the state", Chief Judge Kroll said, adding, "It is with great respect and appreciation that I receive and accept your resignation, and forward to you the best wishes of all the judges of the Fifteenth Circuit. We shall miss you."

last several years dealing with issues created by a change in the way the state finances the court system, shifting the burden of court funding from the counties to the state.



U.S. Justice Alito Visits the Palm Beach Courthouse

Justice Samuel A. Alito, Jr., visited Palm Beach County on January 26th, five days before he was confirmed as Associate Justice of the United States Supreme Court.

Justice Alito lunched at the Kravis Center with fellow judges and lawyers, courtesy of the Palm Beach County Bar Association, and spoke of the confirmation hearings he had endured for the past three months.

After lunch, Justice Alito had requested an opportunity to meet briefly with **Chief Judge Kathleen Kroll** and any interested judges in the Judicial Dining Room at the Central Courthouse. As part of this visit, he joined Chief Judge Kroll for a tour of the courthouse. In a letter of appreciation after his visit, he stated that he had "never seen a better planned or more technologically advanced courthouse."

Florida Justice Pariente Visits the 15th

On February 2nd, **Florida Supreme Court Justice Barbara Pariente** visited the Fifteenth Circuit, interested in the progress made by the circuit's implementation of a Unified Family Court (UFC) and the issues the circuit faces.

Justice Pariente met with **Chief Judge Kathleen Kroll**, UFC Operations Manager **Nicole Saunders**, Family Court Manager **Michelle Spangenberg** and UFC Social Service Coordinator **Mary Quinlan**.

Justice Pariente was especially enthused about the Social Service Component of UFC and applauded the circuit for it's efforts and innovation. The justice stated that she will continue to follow the progress in the Fifteenth Circuit.



COURT PROGRAM NEWS

Family Law Advisory Group

To foster meaningful collaboration between the courts and the community, the Fifteenth Circuit has an active Family Law Advisory Group (FLAG). This committee is comprised of stakeholders from the court, the legal community, service providers and other agencies who are involved in the court system.

Each year, a large group meeting is held and subcommittees are formed based on the issues identified by the group. Several subcommittees were formed this year but most notably, it was decided that the Circuit will host a summit dealing with the Dependency System and a summit to address issues regarding the Court and Legal Community's Interaction with the School Board.

The Dependency Summit will be held on May 4th, and the School Board Summit will be held in late July or early August. As the dates approach, more information will be available.

OSCA Assessing Domestic Violence Issues

The State Court Administrator's Court Improvement Office has initiated a strategic planning process to identify and prioritize domestic violence related issues in Florida's courts and to develop plans to address those issues.

Nicole Saunders, Domestic Violence Coordinator, was selected to participate in a focus group to inform the strategic planning process, and attended a focus group meeting on February 23rd in Tallahassee at the Florida Supreme Court Building. Family Connection

The Family Connection Supervised Visitation Program operates on weekends at the Central Courthouse, and provides three levels of supervised visitation (sight only, sight and sound, and intensive guided interaction). It also provides two levels of monitored exchange, allowing parents to exchange their children in a secure setting without having to interact with each other. Parents in this program have unsupervised visitation with their children, but need a secure, supervised facility where they can exchange their children. Supervised visits are for two hours.

The program is currently serving 34 families, including 50 children, and is without a waiting list. Its location at the Central Courthouse helps enhance the safety of the clients when coming to visitation. An off-duty Sheriff's deputy is onsite during visits, helping staff and families feel more secure.

This past year, the program added an additional fifteen 15 monitors, five of whom are bilingual to serve Spanish speaking clients. The judges have instituted a six-month time limit on orders, with status conferences set at five months to determine if a family should remain in the program. More frequent judicial oversight allows families to address issues that might otherwise be overlooked and helps eliminate the use of the program as a long term solution, which opens up program space to assist more families.

Community Alliance/UFC: A Social Service Component

In 2005, **Chief Judge Kathleen Kroll** and the Community Alliance (CA) of Palm Beach County began collaborating to develop a social service component of the Unified Family Court (UFC). Through numerous workgroups and community meetings, a model was chosen for Palm Beach County.

Mary Quinlan, a licensed clinical social worker, is the Social Service Coordinator for the Unified Family Court Program. Says Quinlan, "We are very excited to announce the implementation of this program on April 2nd."

The CA/UFC Social Service Component is a court-based program that will assist children and families involved in complex cases (identified as more than one court case, with multiple agency involvement) to achieve self sufficiency by convening large group meetings with all agencies/individuals involved with the family, and effectively facilitating the delivery of services.

Development of the program began with an assessment phase which included surveying court files, stakeholders in the community and model programs throughout the country. From assessment, the program moved into a protocol development phase, which is now completed.

On February 14th, the circuit held a large community education meeting about the program with over 45 agency directors in attendance. There was an additional meeting on March 7th to gain input from the agencies to finalize the procedures for the program. Says Quinlan, "We have had a very positive response and invaluable input from local service providers."

Criminal Division News

The Chief Judge has established a Committee that has been charged with streamlining the processing of criminal cases. Individuals from the Judiciary, State Attorney's Office, Public Defender's Office, Public Safety, Clerk and Comptroller's Office, Palm Beach County Sheriff's Office, Criminal Justice Commission and Court Administration attended the committee's first meeting, held February 12th.

Items discussed included: creating a system to check on whether persons with bonds of \$5,000 or less bond out within 3-5 days; creating a system to ensure prisoners are brought over only when actually needed in court for substantive action, and creating a system to allow for release of persons who both the state and defense agree should be allowed out of jail either on bond or due to a plea agreement.

Many of the agencies agreed to additional tasks to ensure the committee goals are met. The next meeting is scheduled for May 10th at 12:00. For more information please contact **Michelle Spangenberg** at 355-4657.

Librarian **Pat Judge** will have an office space to work from and the following services will be available: copiers, Westlaw, fax, TV rental, CLE tape rentals, word processing and stamped envelopes. A document delivery service will be provided through contact with the librarians at the Main Courthouse when possible.

The law library has provided Westlaw and Lexis training to all law clerks and most of the new judges. Training for the public is also being held monthly and all court staff is invited to participate.

2007 Volunteer Mediators' Training "Off to a Great Start"

"Volunteer mediation training is off to a great start for 2007," says Alternate Dispute Resolution (ADR) office Director **Tom Caprio** of the continuing education programs that ADR coordinates for volunteer mediators to meet their certification requirements.

On January 19th, **Judge Peter Evans** taught the basics of Landlord/Tenant law. Mr. Caprio described Judge Evans as "brilliant on the bench" and "a witty and thoroughly engaging educator," adding that the Judge's PowerPoint presentation "was visually entertaining and made the information easily accessible to the mediators."

In February, **Paul Schweinler**, LMHC, NCC, DAPA (a Board Certified Expert in Traumatic Stress) presented a training session on domestic violence issues — which is now a requirement of continuing mediation education recertification. Mr. Caprio notes that most of the small claims volunteer mediators are attorneys or business people, and previously unfamiliar with the material. County Inventory Complete

Court Administration recently completed its annual county inventory reconciliation of fixed assets (property valued in excess of \$1,000). CT System Administrator **Jack Winn III** — under the supervision of Budget & Finance Director **Amy Robinson** — coordinated the barcode scanning of over 1,100 items valued in excess of \$2.5 million. The project was completed on time and exceeded the county requirement that 99% of dollar value be physically accounted for, a feat that is difficult in an environment with many mobile devices, such as laptops.

In addition, **Felix Rodriguez** (Omar) and **James Montada** were responsible for scanning all furniture valued in excess of \$1,000. County inventory reconciliation is a three-month project that occurs mostly after hours to avoid business disruption in the five courthouses. Each member of Court Technology and storeroom staff volunteered for additional shifts starting as early as 6:00 a.m. or ending as late as 10:30 p.m. In addition to the county inventory, staff is also charged with the annual reconciliation of the state inventory.

These positions will provide much needed support for the expanding services to the courts, with an emphasis on quality of service in the satellite courthouses, digital court recording technical quality assurance and developing innovative web services for the judiciary.
