# MESSAGE FROM TRIAL COURT ADMINISTRATOR BARBARA DAWICKE

As the year draws to a close, we have an opportunity to reflect on the highlights of 2009 and to plan for opportunities to come.

Among many noteworthy events this year, the Circuit was honored to have four of its judges elevated to higher court appointments.

Judge Jorge Labarga was named to the Florida Supreme Court, with Judges Cory Ciklin and Jonathan Gerber moving to

the Fourth District Court of Appeals, and Judge Joseph Marx transferring from County to Circuit Court. The Fifteenth Circuit welcomed the appointments of Judges John Kastrenakes, Meenu Sasser, August Bonavita, and Caroline Shepherd, all of whom began their terms in May and June. We were also pleased to learn in December that Magistrate Leonard Hanser was selected to fill the final county court vacancy (see page 4).

July brought the transition to a new chief judge, as **Judge Kathleen Kroll's** term concluded and the judges unanimously elected **Judge Peter Blanc** as her successor. Also this year, the Circuit created a new specialty mental health court division as well as a special foreclosure division (see page 5), added a juvenile drug court program and held successful foreclosure case conferences for pro se litigants. A new tradition was started with the first Columbus Day staff training seminars (see pages 15-16). To a greater extent than ever before, volunteers assisted our staff to complete projects that would have been otherwise unmanageable (see page 18).

Hiring restrictions were modified in November, so that vacant positions may now be staffed following fulfillment of various waiting periods. Unfortunately, budgetary restrictions still preclude travel and legislative consideration of salary raises.

In closing, on behalf of Court Administration, I again thank staff for their ongoing commitment to service and justice for our citizens. I wish the Judges, Judicial Assistants, Court staff, and the justice partners an enjoyable holiday season, with health and success throughout the new year.

Judge John S. Kastrenakes was appointed to the Circuit Court by Governor Charlie Crist on June 1, 2009.

Prior to his judicial appointment, Judge Kastrenakes was a prosecutor with the Office of the United States Attorney in the Southern District of Florida from 1995 to 2009. Before that, he served as an Assistant State Attorney under Janet Reno in Miami from 1981 to 1995.

Judge Kastrenakes received his bachelor's degree in History from the University of Florida, and his law degree also from UF.

Judge Kastrenakes' first assignment is in Criminal Division "V" on the 10th floor of the Main Judicial Center.



TALLAHASSEE – Governor Charlie Crist today appointed Leonard Hanser to the Palm Beach County Court.

"Leonard's legal expertise, calm temperament and solid judgment will be of great benefit as he takes the bench," Governor Crist said. "I am grateful that Leonard is ready and willing to serve the good people of Palm Beach County."



Hanser, 57, has been a general magistrate for the 15th Judicial Circuit since 1993. From 1978 to 1982 and 1989 to 1993, he practiced as a sole practitioner. Hanser practiced privately with Mitchell, Hanser & Schwartz; Mitchell, Hanser, Schwartz & Winkler; and Mitchell, Hanser & Winkler, respectively, from 1982 to 1989. Hanser began his law career in private practice as an associate attorney with Levy, Pilsco, Perry, Shapiro, Keen & Kingcade from 1977 to 1978. He earned his bachelor's degree from the University of Florida and his law degree from the University of Virginia. Hanser will fill the vacancy created by the elevation of Judge Joseph Marx to the 15th Judicial Circuit.

## JUDICIAL ROTATIONS

Effective January 19, 2010, the following assignments will become effective:

#### **Circuit Court**

TD Division and **Judge Lucy Brown** will relocate to Courtroom 11H and to office 11.2208.

**Judge Barry Cohen** continues to fill the vacancy in Criminal Division L created by the appointment of Judge Joseph Marx to the Circuit Court. Once the pending vacancy is filled (see appointment above), it is anticipated that Judge Cohen will resume his duties in the TD Division.

Youth Court is a unique juvenile diversion program run by the Palm Beach County School District's Police Department. The swearing-in ceremony was held in Judge Brown's courtroom in

the Palm Beach County Courthouse, with friends, family, practicing attorneys, and supporters in attendance.

The ceremony held special meaning for Judge Brown and Mr. Arsali, who have remained in touch since their early days in Youth Court.

### MEET THE MAGISTRATES

Magistrates are quasi-judicial officers, who conduct formal court hearings, take testimony and evaluate evidence.

At the end of the hearing, he or she prepares a written report that contains recommendations on action the judge should take in the case. Either party may file a written exception to the report within 10 days. If no exceptions are filed, the court typically enters an order approving the recommendations.

The Chief Judge appoints magistrates, pursuant to Florida Family Rules of Procedures, to hear and make recommendations on post-judgment family law matters and specific prejudgment temporary relief family law matters. The magistrates and hearing officers serve under the direction of the administrative judge of the Family Law Division.

The Chief Judge also appoints a special magistrate to hear and consider Baker Act and Marchman Act proceedings. These proceedings are related to involuntary placement treatment based on a severe mental, emotional or behavioral disorder. The special magistrate serves under the direction of the administrative judge of the Guardianship, Mental Health, Probate & Trust division.





## IN THE COMMUNITY: JUDGE RONALD ALVAREZ

#### A JUDICIAL TOUR OF PLANET JUVENILE

"We will be leaving Earth and traveling to, what I loving refer to as, Planet Juvenile" Judge Ron Alvarez told a Master's level class in Criminal Justice at Florida Atlantic University in Boca Raton. As a guest lecturer, he discussed the role of the judge in the juvenile delinquency system.

"In order to fully understand the role of the judge in juvenile court, one needs to know the parties and participants in a typical juvenile proceeding," Judge Alvarez stated. The normal nonjury criminal proceeding includes: the State Attorney, the defendant, the defense attorney, the judge, clerk of court, and a Sheriff's deputy.

By contrast, a juvenile delinquency matter may involve the State Attorney, the child, the Public Defender, the Office of Regional Counsel or private counsel, the parents or legal custodians, Legal Aid's Juvenile Advocacy Project attorney, the Department of Juvenile Justice probation officer, Palm Beach County School Board courtroom liaison, a Sheriff's deputy, Department of Children and Families case manager, Substance Abuse/Mental Health providers, Office of the Guardian ad Litem attorney, the Guardian ad Litem and Family Violence Intervention Program representative.

Judge Alvarez went on to explain that the role of the judge in juvenile delinquency matters includes keeping the parties and participants organized, acting in the best interest of the child and the safety of the community. Additionally, as the proceedings in juvenile are all non-jury matters, the judge acts as the finder of fact and law and sentencing or disposition authority. When not operating in the delinquency arena, the juvenile judge presides over specialized courts such as delinquency drug court and independent living court.

In order to effectively execute the role of judge in the juvenile division, the judge must have, at the very least, a working knowledge of a number of different disciplines. Knowing the applicable law and procedure accounts for approximately twenty percent of these. The other areas include psychology,

psychiatry, anatomy and physiology, child development, pharmacology, sociology, education, vocational training and social services.

In addition to the responsibilities in the courtroom, the juvenile judge functions outside of the courtroom and in the community in various ways.

In the courthouse, the juvenile judge provides those other members of the Court who are not familiar with Planet Juvenile with practical information concerning the rules and procedures applying to juveniles.

In the community, the juvenile judge serves on the board of directors of various nonprofit organizations dealing with the needs of children or the community in general. Also, from time to time, it becomes necessary to lobby local legislators and those in the state capital for constructive changes to the laws affecting children.

Education of the community and its leaders concerning children and those issues that touch upon their safety and wellbeing and that of the community is another responsibility of the juvenile judge.

Judge Alvarez stated that his years in the juvenile division made clear that there existed one most important responsibility---to encourage the children and their families to be successful, both in and outside of the family.

His final remarks concerned a young lady who was in his juvenile division for two or three years, with whom he had lost contact until about two years ago.

One day, she called to tell him that if anyone ever wondered, he had made a difference in at least one life, hers. Although she had been committed to a maximum security program in the juvenile system and successfully completed it in eighteen months, she went on to receive a scholarship to Palm Beach Community College to play softball, receive her associate's degree, enroll at Florida Atlantic University and receive her bachelor's degree. The next fall she would commence her law studies

Some six months later, she, Ms. Veronica Limia, visited him at the courthouse to tell him that she had completed her first semester in law school, was in the top fifteen percent of her class and had been given the book award in her real property class. She will graduate and take the Florida Bar Exam in 2011. Judge Alvarez volunteered to administer her oath.

He closed his remarks with the following quote of William Arthur Ward:

Flatter me, and I may not believe you.

Criticize me, and I may not like you.

Ignore me, and I may never forgive you.

Encourage me, and I will never forget you.

General Counsel Amy Borman taught seven classes of Third-graders at Morikami Park Elementary School in Delray Beach as part of the Justice Teaching Initiative and the school's unit of inquiry into government.

The classes went through various scenarios including "Who Spilled the Milk?," "The Marker Game," "No Vehicles in the Park," and "Alien Invaders," as part of a discussion of evidence, laws, rules, judicial interpretation, and the Bill of Rights.

Following the classroom discussion, students took a field trip to the courthouse where they observed court proceedings and spoke with Judges Peter Evans, Barry Cohen, Paul Moyle, Joseph Marx and Paul Damico. They also met with the Sheriff's Office K-9 unit and participated in the mock trial of B. B. Wolf v. Curly Pig with Judge Meenu Sasser.

### INAUGURAL DELINQUENCY DRUG COURT GRADUATION

Delinquency Drug Court held its first graduation ceremony on November 18, 2009. The ceremony honored the first two graduates from the program, which began in June 2008 and currently has seven participants.

Delinquency Drug Court is an eight-month (minimum) program comprised of three phases. The program targets youth between the ages of 12 and 16 that have violated their probation, often as a result of misdemeanor drug-related charges. Successful completion requires participation from both the youth and their families who work with treatment providers.

The program requires individual, group and family counseling, as well as regular court appearances, frequent and random urinalysis, written assignments and attending school daily. Progress is reviewed weekly by the Drug Court Team.

## JUVENILE FACILITIES TOUR

On November 2, 2009, **Judge Kathleen Kroll** and **Judge Moses Baker** were joined by Unified Family Court (UFC) Juvenile Case Managers, Assistant State Attorneys, Public Defenders, Office of Regional Conflict Counsel and Department of Juvenile Justice personnel on a tour of juvenile residential facilities.

The tour began in Okeechobee County, where the first stop was at Vision Quest. Vision Quest is a low to moderate-risk girls program that serves female offenders 13 to 18 years of age. The average length of stay at this facility is six to nine months.

The next stop was Okeechobee Juvenile Offender Corrections Center which is a program that serves 64 male high-risk sex offenders. The ages of the youth are 13 to18 years of age. This is a highly structured program, where the average length of stay is 12 to18 months. Some of the offenders prepared a delicious

lunch before the group moved on to the next stop.

Red Road Academy is a low to moderate risk residential program located in a wilderness setting. The program serves committed male offenders, 14 to 18 years of age.

The final stop was the Palm Beach Juvenile Correctional Facility located in West Palm Beach. This facility is a 118 bed residential treatment facility for male offenders between the ages of 13 to 18. Youth Services International operates the program for the Department of Juvenile Justice.

The tour was informative and interesting and gave everyone a unique opportunity to see the variety of services being offered to local youth, and also to observe the dedicated people that work closely with them, providing guidance and discipline.
