# THREE NEW JUDGES TO JOIN FIFTEENTH JUDICIAL CIRCUIT IN JANUARY, 2011

In the August 24, 2010 Primary elections in Palm Beach County, **Lisa S. Small** was chosen to fill the Circuit Court vacancy created by the retirement of **Judge Kenneth Stern**. Judge Small has been assigned to Family Division FD, effective January 4, 2011. Joining Judge Small in the Circuit is her Judicial Assistant, Brenda Gleason.

Voters in the November 2, 2010 mid-term elections chose **Marni A. Bryson** as County Court Judge. Judge Bryson's seat was created by the retirement of County Court **Judge Paul Moyle**. Beginning on Jan. 4, 2011, Judge Bryson is assigned to County Criminal Division E. Working with Judge Bryson as Judicial Assistant is Luciana Vieira.

On December 23, 2010, Governor Charlie Crist announced the appointment of **Gregory M. Keyser** to the Palm Beach County Court. "Greg's extensive legal knowledge and patient demeanor have served him well throughout his 30-year career," said Governor Crist. "I am confident he will bring those attributes to the bench, where he will serve the people of Palm Beach County with fairness, impartiality and integrity."

Keyser will fill the vacancy created by the appointment of **Judge James Martz II** to the Fifteenth Circuit Court. Judge Keyser's commission will become effective January 31, 2011. Divisional assignment has not been confirmed.

Investiture ceremonies will be held in the first quarter of 2011.

# RETIREMENT OF JUDGE PAUL O. MOYLE

On December 31, 2010, **Judge Paul Moyle** retired after 16 years as a County Court Judge.

**Judge Moyle** was appointed to the County Court by Governor Lawton Chiles on June 3, 1994. He took the vacancy previously occupied by Kathleen Kroll.

Prior to his judicial appointment, Judge Moyle was a prosecutor with the Palm Beach County State Attorneys Office.

Judge Moyle received his bachelor degree from Hamline University in 1972 and directly after graduating worked as a road patrol officer in Wrightsville, North Carolina. Then, after working for a land development company in Miami, he attended law school at Cumberland University. It was from there that he was hired as an Assistant State Attorney by David Bludworth.

Diana Grant has served as Judge Moyle's judicial assistant since 1999. Diana will move to Division RE, as Judicial Assistant to Judge Nancy Perez.

# RETIREMENT OF JUDGE KENNETH J. STERN

**Judge Kenneth Stern** retired on December 31, 2010, after serving nine years as a Circuit Court Judge in the Fifteenth Judicial Circuit.

**Judge Stern** was initially appointed to the County Court effective May 3, 1999, by Governor Chiles. His tenure on the Circuit Bench began on January 2, 2002 in the criminal division.

Prior to his appointment Judge Stern was in private practice doing civil and criminal litigation.

Judge Stern attended Ohio University where he majored in Government and received his JD from Cleveland State University. During undergraduate studies, Judge Stern was a Legal Aide in the Ohio Attorney General's office in Cleveland, Ohio. Right out of law school, Judge Stern was a law clerk to the Honorable Judge Joseph Silbert for the Court of Appeals of Ohio, Eighth Appellate District. Following his two-year clerkship, Judge Stern worked for the United States Department of Justice in the Antitrust Division.

# LEGISLATIVE DELEGATION VISIT

The Circuit's annual Legislative Delegation visit took place December 14, 2010. Chief Judge Peter D. Blanc, together with 4<sup>th</sup> District Court Of Appeal (DCA) Chief Judge Robert Gross and Judge Dorian Damoorgian; Chief Judge Victor Tobin of the 17<sup>th</sup> Circuit; and Chief Judge Steven Levin of the 19<sup>th</sup> Circuit hosted the Legislative Delegation at the 4<sup>th</sup> District Court of Appeal. Approximately twenty one Legislative members and their staff participated, including Senator Chris Smith, Delegation Chair and Representative Joseph Abruzzo, Representative Pat Rooney, Representative Mark Pafford, and Representative Irv Slosberg. Also in attendance were the Judges of the 4<sup>th</sup> DCA, Barbara Dawicke, Debra Oats, Tom Genung, Trial Court Administrator of the 19<sup>th</sup> Circuit, Todd Bonlarron, Palm Beach County (PBC) Legislative Affairs Director, and Rachael Ondrus, Executive Director, PBC Legislative Delegation Office. The Judges and the Delegation discussed issues that affect the Courts, including the State budget deficit, the State Court budget, staffing, caseloads, and specialty courts. Following a tour of the 4<sup>th</sup> DCA facility, the Delegation's visit concluded with a presentation by Judge Krista Marx, addressing the Fifteenth Circuit's Drug Court, the Mental Health specialty division, and the Veterans' docket.

Local legislators continue to demonstrate their support of the court's work through this annual event, and generously give their time to learn the current status of court operations in advance of the legislative session.

# CREATION OF VETERANS' TREATMENT DOCKET

PRESS RELEASE - November 10, 2010

#### FIFTEENTH JUDICIAL CIRCUIT CREATES VETERANS' TREATMENT DOCKET

WEST PALM BEACH, FL – Fifteenth Judicial Circuit **Chief Judge Peter D. Blanc** today signed Administrative Order 4.905, creating the first Veterans' Treatment Docket in the Palm Beach County Criminal Justice System. This initiative, spearheaded by Judge Blanc, involves myriad volunteer and agency participants. The signing of the Veterans' Docket Administrative Order coincides with the 235th anniversary of the founding of the Marine Corps. County Court **Judge Ted Booras**, a former Marine, has volunteered to dedicate time to preside over this docket in addition to his existing caseload. The first docket will take place on November 18th.

Modeled after successful drug courts across the Country, the Veterans' docket will provide much-needed assistance to qualified veterans at no additional cost to Palm Beach County or the State of Florida. It will also address root causes of veteran crimes; thereby, reducing recidivism. A Veteran Coordinator, funded by the Veterans' Association (VA), will identify veterans coming through the system and utilize individual evaluations and computer screening to define needs and match them with relevant VA resources. These activities will result in the establishment of customized plans for veterans to resolve existing problems and again become valued, law-abiding citizens.

Veterans are more receptive to the input and guidance of other veterans. In that context, a critical component of the Veterans' docket is the Volunteer Mentor Program made up entirely of veteran volunteers who strongly believe in the credo, "no one is left behind." The Vietnam Veterans of America and Stand Down House are providing training and coordination for this team of volunteers.

#### FLORIDA STATE COURT AND COUNTY LAW LIBRARIES

The 2010 annual conference for Florida State Court and County Law Libraries (FSCCLL) was held in Jacksonville on October 14-16, and hosted by **Kelly Devlin**, Law Librarian of the Eleventh Circuit Law Library.

The focus of the conference was, once again, providing services to self-represented litigants, which is a growing group of law library patrons and a constant challenge for staff.

The **Honorable Gary P. Flower**, Fourth Judicial Circuit presided over the installation of new officers, including Law Library Manager for the Fifteenth Judicial Circuit, **Linda Sims**, who was sworn in as President of FSCCLL.

# COURT REPORTING PRESENTATION AT PALM BEACH COUNTY CRIMINAL PRACTICE COMMITTEE

On September 27, 2010, Court Reporting Manager **Susan Wiggins** was guest speaker at the Palm Beach County Criminal Practice Committee. In attendance were Palm Beach County Judges as well as members of the Bar, with representatives from the Public Defender's office and State Attorney's office of the Fifteenth Circuit. Susan spoke of the importance of capturing the record in the courtroom, whether it be by stenographer or digital court reporter. Both methods produce one ultimate final result; a transcript of the proceedings. Although central recording captures most of the spoken word, a stenographer is able to confirm the spoken word in the moment.

The stenographers of the Fifteenth Circuit also are moving in the direction of providing realtime in the courtrooms, which will enable counsel and the judge to have an instantaneous rough draft English translation of the proceedings. Some benefits of realtime include being able to make personal notations at certain points of testimony, highlighting testimony, and sometimes even walking out of the courtroom with a printed rough draft of the day's proceedings. Realtime benefits the stenographer also because it helps to eliminate the lunchtime research of testimony that may have been missed by counsel, or where a response to a critical question was not heard or is in dispute.

### FAMILY LAW ADVISORY GROUP ANNUAL MEETING

The Family Law Advisory Group (F.L.A.G.) met in the Main Judicial Complex on October 8, 2010, to establish the annual goals for 2010-2011.

The purpose of this group is to improve the operation of the Unified Family Court through the creation of sub-committees which meet during the course of the year. These sub-committees will problem solve, brainstorm alternative approaches, create learning opportunities, work to settle interagency conflicts, and resolve questions regarding various Unified Family Court processes.

Keynote speakers were: Chief Judge Peter Blanc, Judge Catherine Brunson, Administrative Judge of the Family Division, Magistrate Diane Kirigin and Debra Oats-Ducram. There were approximately seventy people in attendance, including judges, magistrates, court staff, attorneys, social service providers, local community leaders, staff of Department of Children and Families, and other interested persons and organizations.

F.L.A.G. participants continue to assist the court by making recommendations to improve the operation of Unified Family Court by volunteering to serve on sub-committees that meet throughout the year to resolve various issues. Three sub-committees were created to address the issues regarding the Family Connections program.

Magistrate Diane Kirigin (pictured right) was elected Chair of the Family Law Section of the Florida Bar for 2010-11. While addressing section members in the fall of 2010, Magistrate Kirigin described the diverse spectrum of legal knowledge required of family law attorneys today, stating, "The skilled family law practitioner is required to master multiple chapters of the Florida Statutes dealing with our practice areas, have at least a working knowledge of the Federal law that affects family law, as well as be knowledgeable about a myriad of substantive areas including but not limited to contract law, real property, probate, insurance, pensions and deferred compensation plans, taxation and bankruptcy."

### CERTIFIED PROCESS SERVER PROGRAM REDESIGNED

Each October, the Circuit accepts applications from individuals wishing to become certified process servers for Palm Beach County.

In 2010, the application process was revised to provide expanded training for new applicants and follow-up training for existing process servers renewing their certifications. Ninety first-time applicants were provided

with a full day of training on December 14, 2010, conducted by Avalon Legal Information Services, Inc. Training was followed by an examination on which applicants must attain a grade of at least 75%.

On December 15, 2010, renewing process servers convened at the Palm Beach County Commission Chambers in the Government Center to attend one of two half-day training seminars. The Circuit expects to renew certifications for approximately 280 existing process servers. Speaking on behalf of the Circuit, General Counsel **Amy Borman** emphasized the need for professionalism and current expertise when representing the court.

The swearing-in ceremony for process servers will be held on January 20, 2011 at the Main Courthouse.

# COLUMBUS DAY TRAINING

The second annual employee Columbus Day training was held on October 11, 2010, at the Main Judicial Center. Trial Court Administrator, **Barbara Dawicke**, assembled a range of training seminars designed to help staff improve their skills while enjoying a day together.

#### **FINANCE**




**Janet Leach-Ruth,** Administrative Services Manager (2007)
