## JUDGE BARRY M. COHEN RETIRES





Side Photo by: Deputy LaFlamme The Honorable Barry M. Cohen, County Judge, retired June 30, 2016, after serving the citizens of Palm Beach County for twenty-five years. Prior to his appointment to the County bench, while in law school, Judge Cohen worked in the Dade County Prosecutor's Office for two and one half years.

After graduating from the University of Miami School of Law, Judge Cohen worked for the Palm Beach County State Attorney's Office in 1971 before moving to the Public Defender's office in 1978. After his work with the PD, Judge Cohen opened a private law office and ran the office of the Public Defender. In 1991, Governor Bob Martinez appointed Judge Cohen to the County Bench where he served with distinction. He will be missed by his colleagues and staff.

## **OPERATION FRESH START**

On Saturday, April 30, 2016, the Fifteenth Judicial Circuit held its first "Operation Fresh Start." Operation Fresh Start is a Circuit initiative aimed at providing an opportunity for misdemeanor defendants to resolve their outstanding warrants and thus avoid jail time. At the May 2016 event, the Judges who volunteered to serve at the event were able to resolve many of the cases. Over 400 defendants appeared for the event. For those defendants who qualified, the Florida Department of Motor Vehicles was on-site to reinstate Driver's licenses

Chief Judge Jeffrey Colbath expressed his appreciation to the Judges who took time out of their weekend to serve and preside over the Operation Fresh Start dockets at the Gun Club facility and the South County Courthouse: the Hon. 

### **Driving with License Suspended**

Judge Frank S. Castor presided over a new specialty docket, Driving While Suspended ("DUS") docket, on May 12, 2016. On this date, a total of 91 defendants appeared before the Court. The DUS docket is ongoing and is calendared each Thursday at 1 p.m. in Courtroom 2D.

The DUS docket is a specialized docket, created to assist individuals by providing information on how to regain their driver's license, and who are also paying their associated court costs and fines. To be considered for the DUS docket, qualified defendants must first sign a deferred prosecution agreement which includes a time frame for compliance. During the compliance period, the defendant must not commit new criminal law violations, must obtain a new driver's license, and pay their outstanding fines and court costs. Upon completion of those requirements, if completed during the compliance period, the State will nolle prosequi the case.


## **Civil Traffic Hearing Officers' Annual Training**



## 2016 LAW DAY MOCK TRIAL: MIRANDA: MORE THAN WORDS

On April 29, 2016, more than 35 students, teachers, and assistants from the Royal Palm School in Lantana traveled to the North County Courthouse for a Law Day Mock Trial. The defendant, Ted Whatley, was charged with breaking into an automobile belonging to Rex Blazer with the intent to commit grand theft. He was also charged with grand theft less than \$5,000 for stealing costumes and a violin.

Judge John Phillips presided, and Judge Richard Oftedal acted as prosecutor during the case. Other volunteers enthusiastically played the role of the victim, the defendant, defense counsel, court personnel, and independent witnesses. The point was to present a modern day trial, with legal issues regarding Miranda rights and musical elements; and, of course to have fun.

The trial was presented in an hour, including the use of video evidence and the some live fiddle music by the victim. The students sat as jurors, and deliberated their verdict while volunteers presented an impromptu acoustic music concert in the well of the court. The jury found the defendant guilty.

Thanks to everyone at Royal Palm School, with special thanks to Judge Philips, Judge Oftedal, teacher Regina Brodsky, and to Justice Teaching volunteer Sheri Hazeltine, Esq., for making this wonderful field trip happen.
