# **DIVISION JS SUMMER PROGRAM**

Judge Luis Delgado and Juvenile Court personnel facilitated the second annual Division JS 2018 Summer program. The goal was to provide a structured, educational experience to hold youth accountable and provide them with the opportunity to earn community service, complete court-ordered sanctions including paying court fees and fines, develop skills, and be linked with community resources and providers. The ten-week program was held on Fridays, from 8:30 am to 3:00 pm, at the South County Courthouse in Delray Beach. In partnership with the South Palm Beach County Florida Association of Women Lawyers and the South Palm Beach County Bar Association, a full-day curriculum was designed to offer community service opportunities, assistance with court/Probation sanctions, and community partnerships and speaker sessions. Breakfast and lunch were provided weekly, birthdays were celebrated and the youth engaged in a number of team-building activities.

Ten youth completed the program, four of whom were successfully terminated from Probation. Entities that partnered with the program included: law enforcement, FAU, Department of Juvenile Justice, FAWL, PBC Fire Rescue, PBC Department of Victim Services, CareerSource, PBC Library, Delray Beach Parks and Recreation, X102.3, PBC School District, South Palm Beach County Bar Association and Sal's Ristorante. Each week, the group earned community service through the creation of greetings cards for veterans; nearly 700 cards service were completed and delivered to the VA Hospital in West Palm Beach. The programming concluded with a Back to School Bash where youth were provided with a brand-new backpack with school supplies.

# **LUNCH AND LEARN**

#### **Sun Safety**

On July 17, 2018, Rita Fox from the Richard David Kahn Melanoma Foundation presented a Lunch & Learn to Circuit employees titled, "Sun Safety." During her presentation, Ms. Fox explained the importance of early detection of skin cancer, of which there are three types: basal, squamous, and melanoma. Melanoma is the least common form of skin cancer, but most deadliest. It is curable if caught early, but statistics show that one person dies of melanoma every hour. Ms. Fox discussed different types of sunscreens, SPF numbers, and continues to spread the word about skin cancer education and routine checkups.

#### Suicide Prevention: Talk Saves Lives

On July 31, 2018, Tara Sullivan Larsen from the American Foundation for Suicide Prevention presented a very important and informative Lunch & Learn to Circuit employees, titled, "Suicide Prevention: Talk Saves Lives." During her presentation, Ms. Larsen discussed that in 2015, suicide was the 10th leading cause of death. For every suicide, there are 25 attempts, and that more often than not, there is usually more than one factor involved (health, environmental, and historical). Ms. Larsen reviewed suicide statistics, research and prevention, and explained what we can do to help someone who is suicidal. #### **American Sign Language**

On September 11, 2018, Brenda Holland, joined by Deborah Gibson, owner of Signs of Excellence, presented a Lunch & Learn to Circuit employees, titled, "American Sign Language." Some of the topics that were discussed were: deaf culture; philosophical models; the role of the professional interpreter in the court system; what constitutes best practice in accommodation; what is going on in your courtroom and why; and practicing cultural humility. Employees also learned a few simple signs and have a better understanding of the how sign language interpreters work with the court system.
