
Institute for Court Management Certification Course

The program has also recently begun offering mentoring services for program participants. Currently, one participant is matched with a mentor and the Circuit has a few mentors ready to be matched.

Juvenile Court Presentation

On March 18th, 2019, Juvenile Court presented to the Palm Beach County Community Alliance at the Children Services Council in Boynton Beach. The Community Alliance is a group of local child and family advocates and community leaders dedicated to increased services, resources, and support for children and families. In May of 2018, the Circuit was fortunate to hire a Permanency Coordinator, Diana Alvarado. For nearly 6 months, she worked vigorously to complete an in-depth analysis of dependency cases, focusing on delays in achieving permanency. At the conclusion of the review, statistical reports were generated and examined by Court staff and Judge Martz. The findings and recommendations were shared with stakeholders at the meeting. The presentation was well-received and resulted in continued discussion and action steps. A special thank you to Judge Martz and Diana Alvarado for their hard work and dedication to this project.


TECH TIPS





How to recall and resend an email:

Oops! It happens to everyone. You sent an email with incorrect information, not enough information, or worse, to the wrong person. No worries, if you act fast you can recall and resend the email.



Here's how:

- ·Quickly go to your "Sent Items" folder, locate the email and double-click to open;
- Click the File button



Note: This feature is **not** guaranteed! An opened email cannot be recalled. Other email systems, such as Gmail, may also be unable to recall.

DEPARTMENT PROFILE

Court Reporting

Accurate, efficient, and customer-service oriented are the three words Melissa Sotillo, Senior Court Operations Manager, used to describe the Court Reporting Services Department, which she oversees. Court Reporting consists of: four court reporters, who transcribe verbatim on capital, first degree murder trials and high profile cases; 15.5 digital court reporters and two contractual digital court reporters, who rotate to a different courtroom every quarter and use technology to capture audio and video of court proceedings, and take log notes on cases; four scopists, who edit, proofread and finalize transcripts; one program coordinator who coordinates transcript work assignments and vendor relationships and one administrative assistant who handles the majority of customer service for the Department.

Unifying such a large team might be a challenge for some, but for this team it is an opportunity to embrace teamwork. Monthly team socials are planned to encourage team building. Recently, nine staff members met on a Saturday to volunteer at the Quantum House by cooking and preparing a brunch for families residing on the property. The following month, staff held a picnic on the front lawn of the historical courthouse and finished with a tour of the historical courthouse.

Some current projects in Court Reporting include unifying the courtroom signage to indicate that digital recordings occur in specific courtrooms, relocating hundreds of archives within the retention period from the seventh floor, and converting backup archives on to a server. In March 2019 alone, over 300 requests for digital recordings were processed plus over 200 hours of court proceedings were covered by court reporters, in addition to the over 1,500 hours of court proceedings that were digitally recorded. Employees in Court Reporting take pride in what they do and the service they provide to ensure an accurate record.
