On Friday, June 3, the Fifteenth Judicial Circuit celebrated the Investiture of the Honorable April Bristow. Despite the tropical storm that was predicted, many of Judge Bristow's family and supporters were able to attend. Chief Judge Kelley presided over the event, administering the Oath of Office. Chief Deputy Clerk Shannon Ramsey-Chessman presented the Judicial Commission on behalf of the Clerk of Circuit Court and Comptroller's Office. Judge Bristow's sister, Dr. Kate Barrier, assisted with the robing. Among those giving remarks on behalf of Judge Bristow were the Honorable Krista Marx, retired Fifteenth Circuit Chief Judge, the Honorable Dorian Damoorgian, 4th District Court of Appeal, and Mr. J. Chris Bristow, Judge Bristow's husband. Each spoke to her tireless work ethic and her devotion to her family.

Judge Bristow gave thanks for this opportunity, adding "I truly care about the law and the judiciary. Our government cannot function without a strong and independent judiciary."

Judge Bristow earned her bachelor of arts in English from the University of Florida and her Juris Doctor from Stetson University College of Law. Prior to being appointed as a county judge, she served as an appellate law clerk to Judge Damoorgian in the 4th District Court of Appeal, and most recently General Counsel for the Fifteenth Judicial Circuit.

Judge Bristow fills the vacancy created by the retirement of the Hon. Sandra Bosso-Pardo. She is assisted by Judicial Assistant Kristina Rosdao and presides over County Criminal Division L at the Judge Daniel T. K. Hurley Courthouse.

Florida Supreme Court Justice Nominee

The Florida Supreme Court Judicial Nominating Commission submitted a short list of finalists to Governor Ron DeSantis on Monday, June 13. Included among the six nominees was Circuit Judge Renatha Francis. Judge Francis was appointed to the Miami-Dade County Court as by Governor Rick Scott in 2017. She was elevated to Circuit Judge with the Eleventh Judicial Circuit in June 2018. She was then appointed to the Fifteenth Judicial Circuit in November 2019.

Governor DeSantis must appoint a new justice to fill the vacancy that was created by the retirement of Justice C. Alan Lawson by August 12, 2022.

Family Drug Court News

Stress and substance use are on the rise. Luckily, Family Drug Court (FDC) is there to offer an avenue for eligible parents in the dependency system to achieve sobriety, and family centered services in a supportive atmosphere. The program provides additional support and services to parents struggling with substance use and helps them reunify with their children in a safe and timely manner.

Exciting things are happening in the FDC program. A brand new logo (right) was designed by Court Technology and was launched as the new face of FDC.

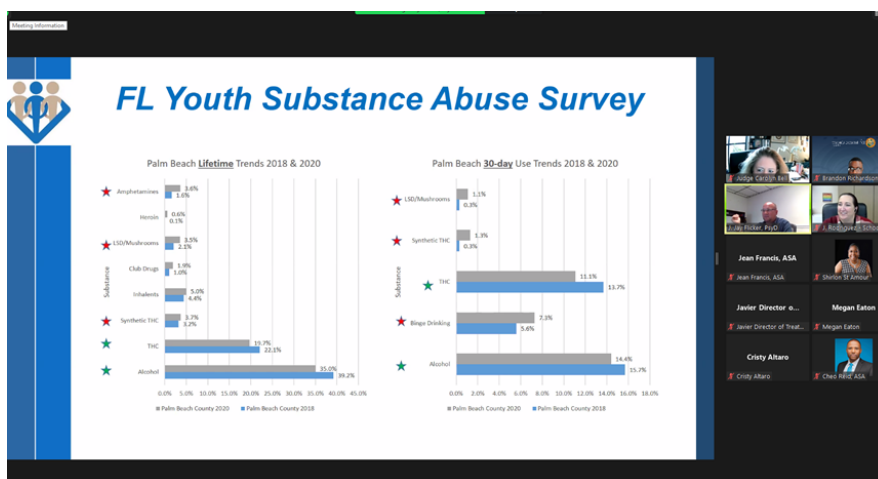
Additionally, FDC has partnered with the Center for Child and Family Futures to review, assist and enhance the program and incorporate best practices. To that end, FDC kicked off vibrant discussions among its multi-agency collaborative, culminating in a series of virtual trainings for its

operational team. Commencing on March 7th, Dr. Marc Schlosser facilitated the first training on Medication Assisted Treatment, also known as MAT. He educated the team members on the methods by which MAT can help to reprogram the brain and realign the neurotransmitters and hormones responsible for substance use addiction and dependence. Dr. Schlosser underscored the importance of participants engaging in other behavior modification therapy in conjunction with MAT in order to achieve and sustain recovery. The second event, held on March 15th, was provided by Dr. Tom Aucoin, a Clinical Toxicologist at Phamatech, Inc. - the Family Drug Court drug testing provider. He delivered an insightful training on the drug testing standards, the chain of custody process for each test and the testing confirmation procedures. Lastly, on April 4th, the Southeast Florida Behavioral Health Network (SEFBHN) delivered an instructive training on the areas of substance use disorder, effective treatment, relapse prevention and long-term recovery. The SEFBHN facilitators entreated the Family Drug Court team to adopt a strength-based and trauma-informed approach in all its interactions with the participants. These trainings have already inspired some practical modifications within the program, and represent a crucial step in developing the competencies of the core team. The FDC team also participated in a two-day, interactive training on Motivational Interviewing in June.



Delinquency Drug Court News

Adolescent substance use continues to be a serious issue around the Country as well as for youth within the delinquency system. At the Fifteenth Judicial Circuit the Delinquency Drug Court (DDC) provides support and resources for youth struggling with substance use. To this end, it is important that the DDC team stays informed of resources and research related to substance use, and that they implement best practices within the program. With the assistance of statewide, problem-solving court funding, the DDC team was afforded the opportunity to participate in several trainings in 2022. The trainings happened on Zoom and addressed an array of topics including substance use trends, Adverse Childhood Experiences (ACEs), and adolescent brain development. DDC extends their appreciation to Jay Flicker from the Drug Abuse Treatment Association Beach for providing the team with fantastic training curriculum and updated substance use materials.

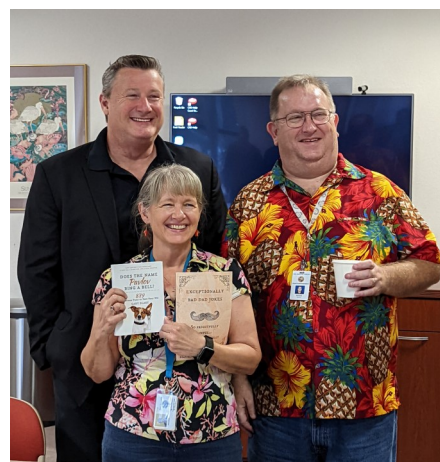

He earned a bachelor's degree from Belmont University in Tennessee and his Juris Doctor from Nova Southeastern University. The Fifteenth Judicial Circuit announces the passing of former County Court Judge Robert V. Parker on June 13th. Judge Parker was born in Des Moines, Iowa and moved to Florida when he was 15. He earned his bachelor's degree from the University of Florida, then served two years of active duty in the U.S. Army. In 1955, he returned to UF for law school. After graduation, he practiced real estate and commercial law in Orlando before moving to West Palm Beach. He was appointed to the County Court by Governor Reuben Askew in 1977. He was re-elected five times, serving 22 years on the bench. He retired in 1999.

Judge Parker was also a 33rd degree Scottish Rite Mason, which is the highest ranking attainable. He enjoyed collecting train memorabilia, taking pictures, hunting turkeys, and spending time with his family. He will be missed by all who knew him.

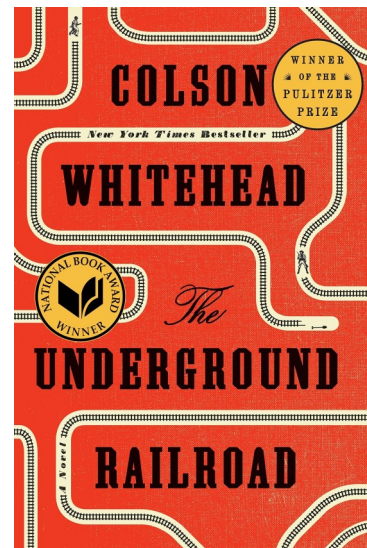
