Judge Shull earned his bachelor of arts from Flagler College and his Juris Doctor from St. Thomas University School of Law. Prior to being appointed as a Circuit Judge, he served as an Assistant State Attorney, and most recently ran his own law firm. Before practicing law, Judge Shull served in the United States Marine Corps, attaining the rank of Sergeant.

On Friday, August 5, Governor Ron DeSantis appointed the Hon. Renatha Francis to the Florida Supreme Court. The vacancy was created by the retirement of Justice Alan Lawson.

Judge Francis was first appointed to the County Bench in the Eleventh Judicial Circuit in 2017 by former Governor Rick Scott. In 2018, she was elevated to the Circuit Bench. She was appointed to the Circuit Bench in the Fifteenth Judicial Circuit in 2019 by Governor DeSantis.

Judge Francis' last day with the Fifteenth Judicial Circuit was August 31. The Circuit wishes Justice Francis the best in her new role.

New Juvenile Education Clinic Launched

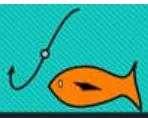
In July 2022, the Juvenile Division introduced a new course to the complement of courses offered in the "Juvenile Education Clinic." Cyber Security, the new course, is now being offered in addition to "Jobs 101; Unlocking your Potential"; and "Know your Record."

Today's youth use the internet in just about every aspect of their lives, from school to entertainment to staying in touch with friends. Many of them lack an understanding of what it truly means to be a responsible digital citizen. Because of this, it is important that youth learn the ways in which what they post online can affect them –now and in the future.

In this clinic, youth learn how to stay safe online, what to post, what not to post, as well as real life consequences of online behavior. Topics covered include but are not limited to: the impact of a digital footprint, how to recognize potential scams and phishing attempts, how to address cyberbullying, and the legal and social consequences of sharing inappropriate content. Fifteen youth attended the Circuit's first ever Cyber Safety Juvenile Education Clinic held on May 19th which resulted in a total of 75 community service hours being earned.

Courthouse Buildout Planning Underway



Palm Beach County held a kick-off meeting for the buildout of the 7th and 8th floors at the Judge Daniel T. K. Hurley Courthouse in West Palm Beach. Chief Judge Kelley, and previous Chief Judges, have requested the much needed buildout in order to provide larger courtrooms for trials and much needed administrative space. The design phase is expected to take 18 months.

The Fifteenth Judicial Circuit supports recovery from opioid and stimulant use disorders through the hard work of our Magistrates, who preside over Marchman Act hearings. Additionally, the Circuit includes three drug courts: Adult Drug Court, Hon. Kirk Volker presiding and Jackson Mack, Drug Court Manager; Family Treatment Court, Hon. Donald Hafele presiding and Debbian Livingstone, Coordinator; Delinquency Treatment Court, Hon. Carolyn Bell presiding and Brandon Richardson, Coordinator.

Digital Signs Installed

There are three types of signs: Wayfinding Signage (located in main hallways to direct courthouse visitors); Display Signage (primarily located in juvenile hallways as a informational board) and Docket Signage (located outside each courtroom). Each Docket sign will display the courtrooms daily docket on the left half of the sign, leaving the right side for announcements and notifications the judge wants to display. Content for these signs can be added by Court Technology, or by a judge/judicial assistant who prefers to update his/her own content.

South County Courthouse, 2nd floor, request assistance from the Law Librarian

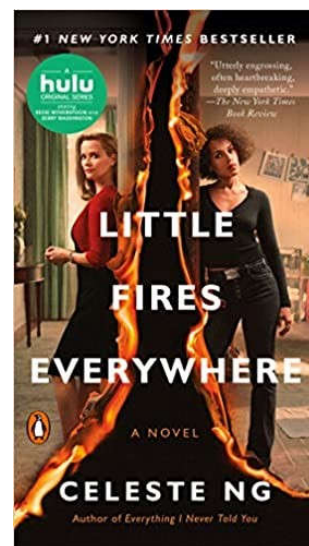
NEW West County Courthouse, 1st floor, request assistance from Mediation
