Judge Sherman's appointment filled the judicial vacancy created by the retirement of Judge Laura Johnson. Judge Sherman is currently assigned to Circuit Civil Division AK.



Fifteenth Judicial Circuit Judges Attend Investiture Ceremony for the Hon. Renatha Francis

On Wednesday, October 18, the investiture ceremony for the Honorable Renatha Francis was held in Tallahassee, FL.
