PER CURIAM.

We grant Appellant, City of Boynton Beach’s Motion for Clarification; withdraw our prior opinion; and substitute the following opinion in its place.

Appellant, the City of Boynton Beach (“City”), appeals a Palm Beach County Court order dismissing Uniform Traffic Citations (“UTC”) issued to Appellees, over 100 named defendants in cases before the Honorable Mark Eissey. Appellees had all been cited for running a red light; infractions the City discovered using its unmanned red-light camera system administered by third-party vendor American Traffic Solutions (“ATS”). The lower court, relying on *City of Hollywood v. Arem*, 154 So. 3d 359 (Fla. 4th DCA 2014), determined this use of a third-party to manage the red-light cameras required dismissal of all the UTCs issued by the City through its arrangement with ATS. *Arem* held that the City of Hollywood’s arrangement with a third-party vendor—ATS—was an impermissible delegation of municipal authority because ATS was itself issuing UTCs, a role reserved for proper law enforcement. 154 So. 3d at 364.

During the pendency of this appeal, the Third District Court of Appeal issued its opinion in *State ex rel. City of Aventura v. Jimenez*, 41 Fla. L. Weekly D1753 (Fla. 3d DCA July 27, 2016). *Jimenez*—a case also involving ATS—distinguished *Arem* and upheld the City of

Aventura's third-party camera system. *Id.* Critically, the Third District noted that, unlike in *Arem*, *Jimenez* involved the use of a "Business Rules Questionnaire" ("BRQ"), a series of guidelines that specifically establish "easily observable" standards for ATS employees to use when determining whether to forward an image to law enforcement. *Id.* Similarly, *Jimenez* involved a contract that (1) specifically stated ATS's role was limited to an initial determination of usability; (2) set forth standards by which ATS could determine which images to forward to Aventura; and (3) set forth that ATS was prohibited from deciding whether a violation occurred. *Id.* The Third District, relying on these distinctions, determined *Arem* was distinguishable and upheld the City of Aventura's use of ATS in administering its red-light camera system. *Id.*

We find that *Arem* is distinguishable from the instant cases for the reasons discussed in *Jimenez*. As in *Jimenez*, here the City's contract with ATS specifically establishes that ATS does not and cannot make any decisions regarding whether a violation occurred. ATS's discretion is similarly limited by the BRQ, which sets forth easily observable standards that dictate whether ATS should forward or otherwise discard images of potential infractions. Most critically, unlike in *Arem*, 154 So. 3d at 364, here ATS does not itself issue the UTC. These distinctions render *Arem* inapplicable to these facts. As *Jimenez*'s facts are analogous to this case, we find that we are bound by its precedent.¹ The trial court's dismissal of the Appellees' UTCs must be reversed.²

On review of the record, it appears that a full hearing occurred, however, in an abundance of caution, we remand this matter for further proceedings. If the parties have no additional

¹ Between the time of our original opinion and this clarifying opinion, the Second District entered its opinion in *City of Oldsmar v. Trinh*, 41 Fla. L. Weekly D2435 (Fla. 2d DCA, Oct. 28, 2016). *Trinh* certified conflict with *Arem*. Because we find the facts of this case distinguishable from *Arem*, *Trinh* neither changes our conclusion nor our reliance on *Jimenez*.

² The Court recognizes the trial court did not have the benefit of the *Jimenez* or *Trinh* opinions when it dismissed the UTCs below.

motions, then the trial court may render a final disposition based upon the existing transcript.

Accordingly, the decision of the trial court is REVERSED and the cases REMANDED for proceedings not inconsistent with this opinion.

BARKDULL, GILLEN, and SASSER, JJ., concur.
